No Increase in Garbage Fees for 2025

Expenses and revenues in the garbage collection fund were analyzed and it was determined that revenues for 2025 will cover the expense of garbage collection and that there is no need to raise the monthly fee charged to residents.

Two factors have made this possible. The first being the new garbage contract entered into a few years ago with Lake Shore Recycling which had more favorable rates than the previous contract and the second being revenues generated by the waste transfer station in the form of "tipping fees" paid to the City.

February is National Spay/Neuter Month

The Department of Animal & Rabies Control will be offering a rebate for spay/neuter costs in the month of February.

The Cook County Department of Animal & Rabies Control are doing their part to help solve our country's pet overpopulation problem. Cook County residents can have their dogs, cats, or ferrets spayed/neutered during the month of February and save \$40 through their veterinarian.

How the rebate program works:

- 1. You must be a Cook County resident.
- 2. Call your veterinarian to ask if she/he is participating in the Cook County spay/neuter rebate program.
- 3. Schedule an appointment in February with a participating veterinarian.
- 4. Bring your cat, dog or ferret in for spay/neuter surgery. Limit is two pets per household.
- 6. All pets must either receive a rabies vaccination and tag the day of surgery or have a current rabies vaccination and tag to qualify for the program.

Contact your local veterinarian for more information. Or you can go to the County site at *CookCountyIL*. *gov/service/spay-and-neuter-program-0*.

In addition, for Northlake residents only, bring your cat or dog in to a participating veterinarian to be spayed or neutered, anytime during the year, and you will receive a \$20 rebate from the City of Northlake. To participate in the program, your pet must be inoculated with the rabies vaccine. To receive your \$20 rebate from Northlake City Hall, you must bring in proof of residency and proof of the procedure from your veterinarian including a receipt.

This is followed with an assessment by independent assessors with significant public safety experience. Additionally, public feedback is received to promote community trust and engagement. Structured interviews are conducted with select agency personnel and others with knowledge to assess the agency's effectiveness and overall service delivery capacities. The decision to accredit is rendered by a governing body of twenty-one Commissioners following a public hearing and review of all reporting documentation.

CALEA Accreditation is a continuous process and serves as the foundation for a successful, well managed, transparent, community-focused public safety agency. To this end, an agency must maintain its accredited status by remaining in compliance with CALEA standards at all times.

Heating Safety Tips

Heating equipment is one of the leading cause of home fire deaths. Half of home heating equipment fires are reported during the winter months. Some simple steps can prevent most heating related fires from occurring.

- Keep anything that can burn at least 3 feet away from heating equipment, like the furnace, fire-place, wood stove or space heaters.
- Never use your oven to heat the home.
- Remember to turn portable heaters off when leaving the room or going to bed.
- Always use the right kind of fuel for fuel burning space heaters.
- Have a qualified professional clean and inspect your furnace and fireplace very year.
- Make sure the fireplace has a sturdy screen to stop sparks from flying into the room. Ashes should
 be cool before putting them in a metal container. Keep the container a safe distance away from your
 home.
- Test smoke alarms at least once a week.

PARKING

City regulation states that there will be no parking on all streets between 2:00 a.m. and 6:00 a.m. Also, on north-south streets, there is no parking on the west side of the street at any time. On east-west streets, there is no parking on the north side of the street at any time.

Garbage Pick Up

Occasionally, you may have additional items or cans which may be placed for pick up if they have a tag attached to them. The cost of the tag is \$1.50 each and will be available at City Hall (55 E. North Avenue), Walgreen's (North and Wolf) and Public Works (100 W. Palmer).

Yard waste must be placed in brown paper yard waste bags or a container NOT larger than 33 gallons (maximum weight -60 pounds). Yard waste in plastic bags or oversized containers will not be picked up.

If you have metal items, such as appliances, water heaters, storm doors, lawn furniture, etc. you should place these items out on Thursday without a tag as the recyclers will most likely pick up these items quickly. You can always add a tag in the morning.

Just a Reminder

All electronic items must be disposed of at Public Works, 100 W. Palmer. Do not leave them out for garbage collection. They will not be picked up. For televisions with picture tubes and old style glass computer monitors, you must purchase a sticker from City Hall or Public Works. The cost is \$5.00. The sticker must be affixed to these items. There is no charge for any other item. Public Works is open 7:30 to 3:00 Monday through Friday.

Why Does The Snow Plow Deposit Snow At The Edge Of My Driveway?

Public Works in most towns use angled snow plows for snow removal. The major advantage of a side-angle plow is that it enables efficient and rapid snow removal. With this type of plow it is not possible to prevent a pile of snow from forming in front of a driveway. Drivers cannot lift their plows at driveways during snow removal. Doing that would increase the time it took to remove the snow from the streets and would leave piles of snow that could create a dangerous driving condition.

Though this may be an inconvenience for some, it is a necessary tradeoff for the removal of snow from the rest of the street.

Cook County Treasurer Urges Seniors to Take Advantage of Property Tax Deferral Program

Amid growing concerns that increases in property tax bills are pushing senior citizens to leave their homes, Cook County Treasurer reminded senior homeowners today of a state program that allows them to defer paying their property taxes.

The Senior Citizens Property Tax Deferral Program allows property owners aged 65 or older to "borrow" money from the state to cover their property taxes. This program operates as a loan with a simple annual interest rate of 3%, providing financial relief to eligible seniors.

"Our senior homeowners are finding it increasingly difficult to pay their taxes. This program can make the difference among staying in their home, falling behind on their taxes or selling their home."

To be eligible, property owners must meet the following criteria:

- Be 65 years of age or older on June 1 of the year the application is filed.
- Have an annual household income of \$65,000 or less.
- Have lived in the home for the past three years.
- Have no overdue property taxes or pending special assessments.
- Have adequate fire or accident loss insurance.

The program allows deferring up to \$7,500 annually in property taxes. If the bill is greater, the homeowner is responsible for paying the difference. Deferred taxes must be paid immediately upon the sale or transfer of the property, or within one year after the taxpayer's death.

Applications for fiscal year 2024 will be available in January 2025 and must be submitted by March 1, 2025.

At cookcountytreasurer.com under the "Seniors" tab, you can find information about the program, a link to a downloadable brochure and an application that can be printed. In addition, the Cook County Treasurer's Office has created a video in English, Spanish and Polish on the website and social media platforms.

Recently, lawmakers reduced the program's interest rate by half to 3%. Previously, participants paid an annual interest rate of 6% for fiscal years 2022 and earlier. Additionally, the maximum deferral limit increased from \$5,000 to \$7,500, while the annual income household for eligibility rose from \$55,000 to \$65,000.

Trees for Spring 2025

Trees for the Fall, 2024 planting are complete. If you have room on your parkway to provide a home for a tree for spring, 2025, call Public Works at 708-562-0940 to pick from the list of trees for the spring planting. Trees absorb storm water runoff, absorb various pollutants, produce oxygen and help reduce summer temperatures. Trees also improve property values as well, and studies have indicated that a block with mature trees also tends to slow down traffic. Trees also absorb and reduce urban noise – produced by airplanes, cars and other sources.

Remember – trees located on the parkway or in the City's right of way cannot be cut or trimmed without the permission of the City. The right of way is generally the area 20 feet from the back of the curb. If in doubt, or if a tree in this area needs attention, call Public Works at 708-562-0940.

Those interested in Grass Cutting must use this form. **Grass clippings will not be raked up.**


