

City Desk by Jeffrey T. Sherwin No Increase in City's Share of Property Tax Bill

In December, the City Council approved the 2023 budget and tax levy. The budget provides that all operating and infrastructure maintenance and investment could be accomplished without increasing the City's share of the property tax bill for the fifth year in a row. The City's share of the tax bill is roughly 11% of the total. In addition, the City Council voted to abate all debt service (bond) tax levies for the next year.

The budget reflects the City's strong budgetary performance and equally strong reserve position. The new budget provides for more than \$6 million in capital investment (infrastructure), in particular, a substantial water main replacement project in the residential area behind City Hall which was first developed in the late 1930's.

In addition to significant infrastructure improvements, the budget also provides for a substantial Police Pension contribution of just over \$1.5 million which will help meet the City Council's long range priority of reaching 100% funding well before the statutory requirement of 2040.

Congressmen Jesus "Chuy" Garcia and Mike Quigley Secure Grant for City

Congressmen Jesus "Chuy" Garcia and Mike Quigley secured funding for sanitary sewer rehabilitation for the City of Northlake in the amount of \$3.2 million. The Northlake grant was part of the fiscal year 2022 Funding Bill passed by the U.S. Congress in December. Congressmen Garcia and Quigley secured approximately \$43.5 million in funding for various community based projects in their districts as part of the overall Federal investment package.

City, Water Reclamation District Announce New Partnership

The City and the Metropolitan Water Reclamation District (MWRD) have entered into a partnership agreement for the installation of permeable pavers for the parking areas at Millennium Park along Wolf Road and LaPorte Avenues. Once completed, the parking areas will be able to retain over 33,000 gallons of storm water for each rain event rather than having this run off end up in the City's storm sewers and ultimately in the creek. The agreement provides that the MWRD will provide \$361,000 in funding for the project which represents approximately 80% of the cost. The project will be built this year.

Back Yard Chicken Update

After the mail in ballots were counted by the Cook County Clerk, the back yard chickens increased their margin of victory from 1 vote to 4 votes with the final result being 1,019 in favor and 1,015 against. A City Council Committee, chaired by Alderman Penny Feldmann, will be researching the issue and will forward recommendations to the City Council.

Property Tax Due Date

Cook County property owners will have an extra month to pay their First Installment property taxes this year. HB 5189 makes Monday, April 3, 2023, the new due date. Property taxes are mailed twice a year. First Installment bills are usually due on March 1, and are 55% of the previous year's total amount.

First Installment bills will be mailed out in late February or early March, but bills are available right now at cookcountytreasurer.com for payment or viewing.

To make a payment or download a copy of you tax bill, visit cookcountytreasurer.com:

- Select the blue box labeled "Pay Online for Free"
- Search by property address or enter your Property Index Number
- There is no fee if you pay from your bank account
- Payments made at cookcountytreasurer.com before 11:59 p.m. on April 3 will be recorded as on time.

Partial payments are accepted. Late payments are charged 1.5 percent per month, as required by Illinois law.

February is National Spay/Neuter Month

The Department of Animal & Rabies Control will be offering a rebate for spay/neuter costs in the month of February.


The Cook County Department of Animal & Rabies Control are doing their part to help solve our country's pet overpopulation problem. Cook County residents can have their dogs, cats, or ferrets spayed/neutered during the month of February and save \$40 through their veterinarian.

How the rebate program works:

- 1. You must be a Cook County resident.
- 2. Call your veterinarian to ask if she/he is participating in the Cook County spay/neuter rebate program.
- 3. Schedule an appointment in February with a participating veterinarian.
- 4. Bring your cat, dog or ferret in for spay/neuter surgery. Limit is two pets per household.
- 6. All pets must either receive a rabies vaccination and tag the day of surgery or have a current rabies vaccination and tag to qualify for the program.

Contact your local veterinarian for more information. Or you can go to the County site at *CookCountyIL*. *gov/service/spay-and-neuter-program-0*.

In addition, for Northlake residents only, bring your cat or dog in to a participating veterinarian to be spayed or neutered, anytime during the year, and you will receive a \$20 rebate from the City of Northlake. To participate in the program, your pet must be inoculated with the rabies vaccine. To receive your \$20 rebate from Northlake City Hall, you must bring in proof of residency and proof of the procedure from your veterinarian.

Trees Available for Spring 2023

Trees for the Spring, 2023 planting are available. If you have room on your parkway to provide a home for a tree, call Public Works at 708-562-0940 to pick from the list of trees for the spring planting.

Trees absorb storm water runoff, absorb various pollutants, produce oxygen and help reduce summer temperatures. Trees also improve property values as well, and studies have indicated that a block with mature trees also tends to slow down traffic. Trees also absorb and reduce urban noise – produced by airplanes, cars and other sources.

Remember – trees located on the parkway or in the City's right of way cannot be cut or trimmed without the permission of the City. The right of way is generally the area 20 feet from the back of the curb. If in doubt, or if a tree in this area needs attention, call Public Works at 708-562-0940.

Heating Safety Tips

Heating equipment is one of the leading cause of home fire deaths. Half of home heating equipment fires are reported during the winter months. Some simple steps can prevent most heating related fires from occurring.

- 1. Keep anything that can burn at least 3 feet away from heating equipment, like the furnace, fireplace, wood stove or space heaters.
- 2. Never use your oven to heat the home.
- 3. Remember to turn portable heaters off when leaving the room or going to bed.
- 4. Always use the right kind of fuel for fuel burning space heaters.
- 5. Have a qualified professional clean and inspect your furnace and fireplace very year.
- 6. Make sure the fireplace has a sturdy screen to stop sparks from flying into the room. Ashes should be cool before putting them in a metal container. Keep the container a safe distance away from your home.
- 7. Test smoke alarms at lease once a week.

BUILDING DEPARTMENT

Many home owners will be taking on home improvement projects. If you are having work done on or in your home, please remember the following permit and code requirements:

Hours for construction are 7:00 a.m. - 6:00 p.m., Monday - Friday and 9 a.m. - 5 p.m. on Saturday and Sunday. Typically, a permit is required for the following common projects: additions, bathroom remodels, decks, driveways, electrical upgrades, fences, kitchen remodels, patio, patio cover/overhangs, roofs, sewer, sheds, siding/gutters/downspouts and window replacements.

Application Requirements:

- Application: Filled out completely.
- Plat of Survey: Submitted along with all permits for all outside projects (new construction, additions, fence, patios, decks, driveways & sheds.
 Plat of Survey must be current and reflect all structures on the property. Applications will be denied if a current plat of survey is not submitted with the application.
- **Site Plan:** Required for new construction, drawn to scale, with the building dimensions noted. The site plan can be shown on the plat of survey. New construction plans are reviewed by a consulting building official.
- **Engineering / Grading Plan:** Required for new construction. Engineering/grading plans are reviewed by a consulting engineering for storm water management compliances.

All engineering review fees are paid by the building permit applicant.

- **Topographical Survey**: Flood zoned residents are required to provide this survey for any new outdoor projects or any alteration.
- Copy of Contract or Estimate: Details the scope of work and the cost of the job.
- **Contractor's License:** All contractors are required to be listed on a permit application and be registered with the City.
- **Permit Card:** Required to be displayed in a window or door that faces the street and is un-obstructed. Failure to display the permit card will result in a fine.
- **J.U.L.I.E.:** Please call before you dig, **811 or (800) 892-0123**. It's FREE & they will arrange to come to your property and mark the locations of the underground utilities.

Inspections: Inspections will be listed on the Permit Card. The owner/contractor is responsible for obtaining all inspections. Failure to call for an inspection can result in dismantling of finish surfaces or removal of drywall for inspection purposes. It is recommended that a homeowner does not make their final payment to their contractor until a final inspection has been completed and approved. This protects the homeowner by ensuring that the contractor has done the work according to the plans approved by the Building Department and the City Code.

Permits shall become invalid if work does not start within 6 months, see expiration date on permit card. If work has been started, the permit is valid for 1 year from day of issuance.

Reduce, Reuse, Recycle

Benefits of donation:


- Prevents usable goods from going into landfills

Recycling is the process of collecting and processing materials that would otherwise be thrown away as trash and turning them into new product.

Benefits of recycling include:

- Conserves natural resources such as timber, water and minerals.
- Increases economic security by tapping a domestic source of materials.
- Saves energy
- Prevents pollution by reducing the need to collect new raw materials.
- Supports American manufacturing and conserves valuable resources
- Helps create jobs in the recycling and manufacturing industries in the U.S.

Curbside recycling is very common. Check with City Hall for a complete list of recyclable materials. The City also collects pharmaceutical drugs for proper disposal at the Police Department drop box. You can also recycle electronic waste at Public Works located at 100 W. Palmer.

Prescription Drug Drop Off Box at Police Dept.

It may not be safe to dispose of medications by flushing them down the toilet or pouring them into the sink. It could be polluting the waterways in Illinois. The Metropolitan Water Reclamation District has seven water reclamation plants working to treat discarded water leaving the homes in the Chicago area. The process can remove many things, however, it is not designed to deal with prescription drugs. So they are returned to the waterways in Illinois.

Return unwanted or expired medication to a take-back program. This is the most environmentally safe way to dispose of these medications and will keep seniors, children and pets safe. The Northlake Police Department has a drop box located on the north end of the building. Drug drop off is anonymous and available 24 hours a day, 7 days a week.
