

## City Desk by Jeffrey T. Sherwin Referendum Results Provide Some Guidance to City Council

The City of Northlake had two advisory referendums on the November 8, 2022 ballot. The first question was whether to allow backyard chickens. The vote was almost evenly split with 1007 "no" votes and 1008 "yes" votes, resulting in no clear mandate for either direction. A City Council committee will study the matter and will investigate how other communities have dealt with the issue and report back to the full City Council before spring, 2023

The other question, dealing with regulating live bands and amplified music in the residential area resulted in 1169 votes in favor of regulation and 846 votes against. These results were more clear cut in giving the City Council direction in this area. This matter has been before the City Council many times and has no

easy answer that will please everyone. Certainly residents should be allowed to have parties and be able to enjoy their yards with music as part of the mix.

Other residents are also entitled to enjoy their property in peace and quiet with the windows open during the summer time.

The problem arose due to inconsiderate neighbors playing music well past 10 p.m., sometimes past midnight, at volumes that could be heard several blocks away, sometimes every weekend.

Over the winter, the City Council will craft some sort of regulations to cover live bands and amplified music, most likely with a cut off time, level of volume, number of times per year and other common sense regulations. The City Council will also look at what other communities do in this area as well. Hopefully some sort of reasonable regulations will be in place by spring.

These are issues that not everyone will be able to agree on, but hopefully a consensus will be reached going forward.

On another matter, our Operation Round Up program for water bills has been in operation for a little less than 2 years. Approximately \$3,500 has been raised in this period, and 17 residents received assistance with their water bills as a result.

The program is simple. If you opt in, your water bill is rounded up to the nearest dollar amount with the spare change going into the assistance fund. For example, if your bill is \$53.43, it would be rounded up to \$54.00 with the additional .57 cents going into the assistance fund. There are six water bills per year, so the most anyone would contribute would be \$5.94 per year, (if all of your bills ended up in .01), the least anyone would contribute would be 6 cents, if all their bills ended up at .99 cents. The program is voluntary and you can opt out at any time.

## **New Smoke Detector Law**

Effective January 1, 2023, a new state law will require that all battery powered smoke detectors (i.e., those that are not hardwired) must be replaced with detectors that feature self-contained, non-removable, 10 year sealed battery.

This will apply to single family, multi-family, rentals, condominiums and town homes. The law requires that a smoke detector be placed inside every bedroom and also outside the bedrooms within 15 feet of the bedroom doors. One detector is required per story, including basements but not including unused attics.

Those exempt from the requirement are: home with hardwired smoke alarms or smoke alarms running on Wi-Fi or low powered radio frequencies.

## **Christmas Recycling List**

Even if you have been a good recycler all year long, what to do with holiday decorations and gift wrap may present a challenge. Here is the list of recyclable and non-recyclable.

Recyclable: Gift boxes, tissue paper, shoe boxes, holiday cards/envelopes, gift bags

(paper) and wrapping paper (non-metallic).

Non-recyclable: bubble wrap, foam peanuts, ribbon and bows, sticky gift labels, coated gift

bags, metallic wrapping paper, soiled disposable tableware, tree decorations.

## **House Numbers**

Time can be critical in an emergency and responding fire and police personnel must be able to find your address quickly before they can help you. Northlake City Ordinance states that you must have numbers (not words) that have to be at least 2 1/2 inches tall. However, the police and fire strongly urge larger numbers (four to six inches) to make visibility greater. Numbers in cursive are especially difficult to read at night or during stormy weather.

## Prescription Drug Drop Off Box at Police Dept.

It may not be safe to dispose of medications by flushing them down the toilet or pouring them into the sink. It could be polluting the waterways in Illinois. The Metropolitan Water Reclamation District has seven water reclamation plants working to treat discarded water leaving the homes in the Chicago area. The process can remove many things, however, it is not designed to deal with prescription drugs. So they are returned to the waterways in Illinois.

Return unwanted or expired medication to a take-back program. This is the most environmentally safe way to dispose of these medications and will keep seniors, children and pets safe. The Northlake Police Department has a drop box located on the north end of the building. Drug drop off is anonymous and available 24 hours a day, 7 days a week. ## What Is The Northlake Cares Program?

The Northlake Cares program is a voluntary registry for vulnerable populations in our city. The program enables the Police Department as a partner, to obtain critical information which assists an officer in responding to calls for service involving an individual with Alzheimer's disease, blindness, autism, Down's syndrome, deafness, attention deficit/hyperactivity disorder (ADHD), and other physical and developmental disabilities which may affect the way individuals interact and respond to law enforcement officers.

Benefits to the Northlake Cares program include providing peace of mind to caregivers, promoting officer safety and helping us to better interact with service calls involving individuals with medical and/or developmental disabilities.

#### **How It Works**

Northlake Cares is voluntary for those participating and all information is kept confidential. Information entered by residents into the Northlake Cares application is added to our current police records management system. Special situations remarks are also included, along with other information for the specific address provided by the resident. When our local communications center receives a call for service and the address is associated with an address previously registered in our Northlake Cares system, our local dispatchers will indicate this is Northlake Cares address to our responding officers and EMS.

## **Partnerships**

Key to the success of the program are the strong partnerships formed with our police department, our special needs community and loved ones and referral agencies.

## The 411 on Recycling

The new recycling carts that replace the smaller recycling bins have been a success. Many people have commented that the community looks neater and cleaner.

To keep Northlake's recycling program on a successful track, we are asking that you do your part. **Household** waste should never be placed in the recycling carts. Doing so, contaminates recyclable materials and the recycling cart will not be emptied.

The system works best when everyone does it correctly. Here are a few reminders about the recycling program:

- Use only the recycling carts that have been provided. However, additional recyclables that do not fit in your cart can be collected in another recycling bin or paper bag.
- All containers to be recycled should be rinsed and free of food.
- Broken down cardboard boxes can be placed next to the cart.
- DO NOT use recycling carts for any other type of refuse.

Below is a list of items that can be recycled in the Northlake program. Many items that are not accepted may be recycled by other means. Contact city hall at 708-343-8700 for more information.
